We provide expertise, advice and practical support to innovators, for example:

- Advice on how change is delivered in the NHS and support with navigating information governance issues
- Support to develop a benefits case and case for change to enable clear communication with stakeholders

- Using data to support you to understand the healthcare need – what problem are you addressing and how big is it?
